10 7.3 Single Family Residential – marital home

11 16723 SYCAMORE ST, HESPERIA, CA 92345-2143 (hereinafter “Sycamore home”)

12 On August 21, 2018, the prior owners (Arturo Quintero and Antonia Casas) of the
13 Sycamore Home executed a grant deed to JORGE CISNEROS, Married Man as his
14 sole and separate property (decedent); the grant deed was recorded on October 4, 2018.
15 This has been the marital residence since the date of purchase.

16 7.4 Bank Accounts

17 7.4.A My husband had various bank accounts in his name only at both Bank of
18 America and Wells Fargo Bank. I have already demanded for the bank to give
19 me the money from those accounts as I believe I am the payable on death
20 beneficiary. I expect to get a reply from both banks after October 27, 2022.

21 7.4.B All of these bank accounts in Wells Fargo Bank and Bank of America were
22 established by my husband after we were married. He used funds from his job
23 to fund the account and deposited his income earned during the course of our
24 marriage.

25 7.4.C If the bank account balances are paid to me prior to my spousal petition
26 hearing, I shall withdraw this request.

27 7.5 There were no other deeds or transfers after the decedent became the sole owner of the
28 aforementioned real property.

7.6 At the time of the purchase of SYCAMORE HOME, I did not qualify for a home loan since I was a homemaker and did not have any income history, so I was not placed on title. The agreement for the purchase of the two real properties were purchased during the marriage is that they would be purchased with community funds in the name of my spouse (the decedent) since we were married, and the real property would belong to the both of us.

7.7 On June 30, 2010, my husband and I bought our first real property together for \$92,000. The home address was 9947 3rd Ave., Hesperia, CA 92345. The home was purchased in my husband's name only since I did not have any income history or credit. Title to that home was vested as: "JORGE CISNEROS, Married Man as his sole and separate property."

We sold this 3rd Ave home on September 28, 2018 for \$180,000; after paying off the mortgage, we used the sale proceeds to pay \$24,000 down payment toward the SYCAMORE HOME that I currently reside in. My husband signed a mortgage for \$238,500—the monthly \$1,400 payments are current.

7.8 A description and the approximate values of real and personal property owned by the decedent on the date of marriage and a statement concerning the disposition of same are attached in 7a and 7b.

7.9 Decedent and surviving spouse have been residents of California since 2004.

7.10 The petition affects title to real property, and a statement concerning the status of record title to real property at the decedent's date of death is attached.

7.11 The Petition affects title to real property commonly known as 16723 SYCAMORE ST, HESPERIA, CA 92345-2143, and a copy of the deed(s), recorded on October 4, 2018, showing vesting at the decedent's date of death are attached.

7.12 The surviving spouse's entitlement to the decedent's interest in property is based upon intestate succession since the real properties are community property and there is no will pursuant to Probate Code section 6401.

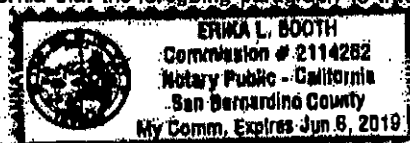
